- MAX: 6.000.000 EUR
- EU contribution going to **SME(s)** shall be 30% or more of the total estimated EU contribution for the project as a whole

Paediatric conduct disorders

- **Collaborative project:** small or medium-scale integrating project
- MAX: 6.000.000 EUR
- EU contribution going to **SME(s)** shall be 15% or more of the total estimated EU contribution for the project as a whole

Epilepsy

- **Collaborative project:** small or medium-scale integrating project
- MAX: 12.000.000 EUR
- EU contribution going to **SME(s)** shall be 15% or more of the total estimated EU contribution for the project as a whole

Pain

- **Collaborative project:** small or medium-scale integrating project
- MAX: 6.000.000 EUR

Stage 1:

Outline proposals (6 pages)

2 evaluation criteria:

- S&T quality
- Impact

Evaluation:

- *Eligibility check* by the Commission
- *Individual remote evaluation* by experts
- *Consensus meeting* in Brussels and elaboration of consensus reports and score for all proposals
- Information sent to successful applicants and *invitation to submit a full proposal*
- Information sent to unsuccessful applicants

Only the best outline proposals go to stage 2

Stage 2:

Separate and independent evaluation from stage 1
(scores achieved by stage 1 outline proposal are not taken into account at stage 2 evaluation)

Full proposals

3 evaluation criteria:

- S&T quality
- Implementation
- Impact

Evaluation:

- *Eligibility check* by the Commission
- *Individual remote evaluation* by experts for each topic
- *Consensus meeting* in Brussels and elaboration of consensus reports for each topic
- *Panel meeting* to agree on ranked list of proposals for brain topics
- *Information sent to proposers:* selected for funding
reserve list (if applicable)
not selected

1) PROJECT EVALUATOR: FP7-HEALTH-2013-INNOVATION-1

Evaluation Stage 2:

Criterion 1: S/T excellence

- Soundness of concept, and quality of objectives
- Progress beyond the state-of-the-art
- Quality and effectiveness of the S/T methodology and associated work plan

Overall score
(Threshold: 4/5)

Criterion 2: Implementation

- Appropriateness of the management structure and procedures
- Quality and relevant experience of the individual participants
- Quality of the consortium as a whole (including complementarity, balance)
- Appropriateness of the allocation and justification of the resources to be committed (staff, equipment,...)

Overall score
(Threshold: 3/5)

Criterion 3: Impact

- Contribution, at the European [and/or international] level, to the expected impacts listed in the work programme under relevant topic/activity
- Appropriateness of measures for the dissemination and/or exploitation of project results, and management of intellectual property

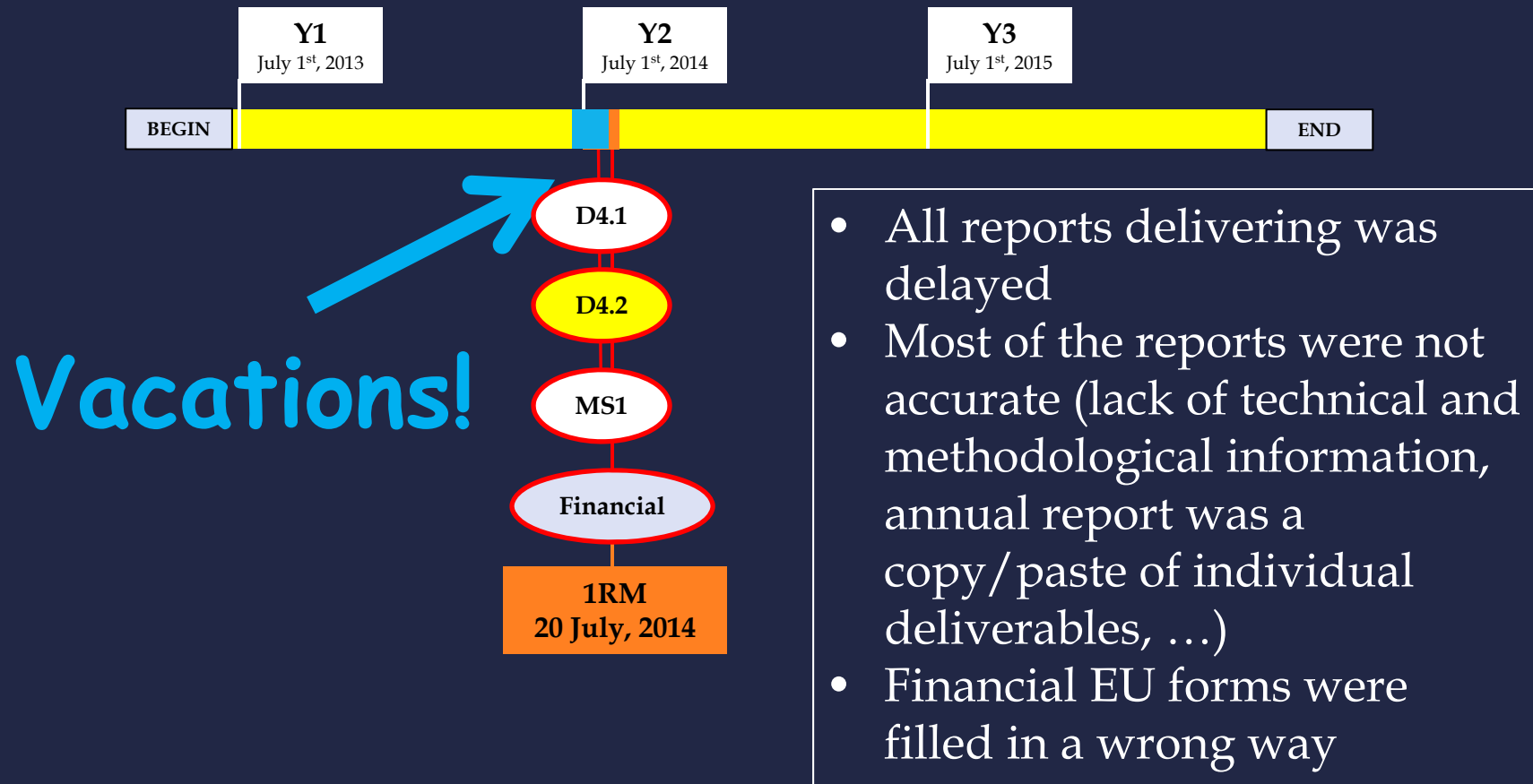

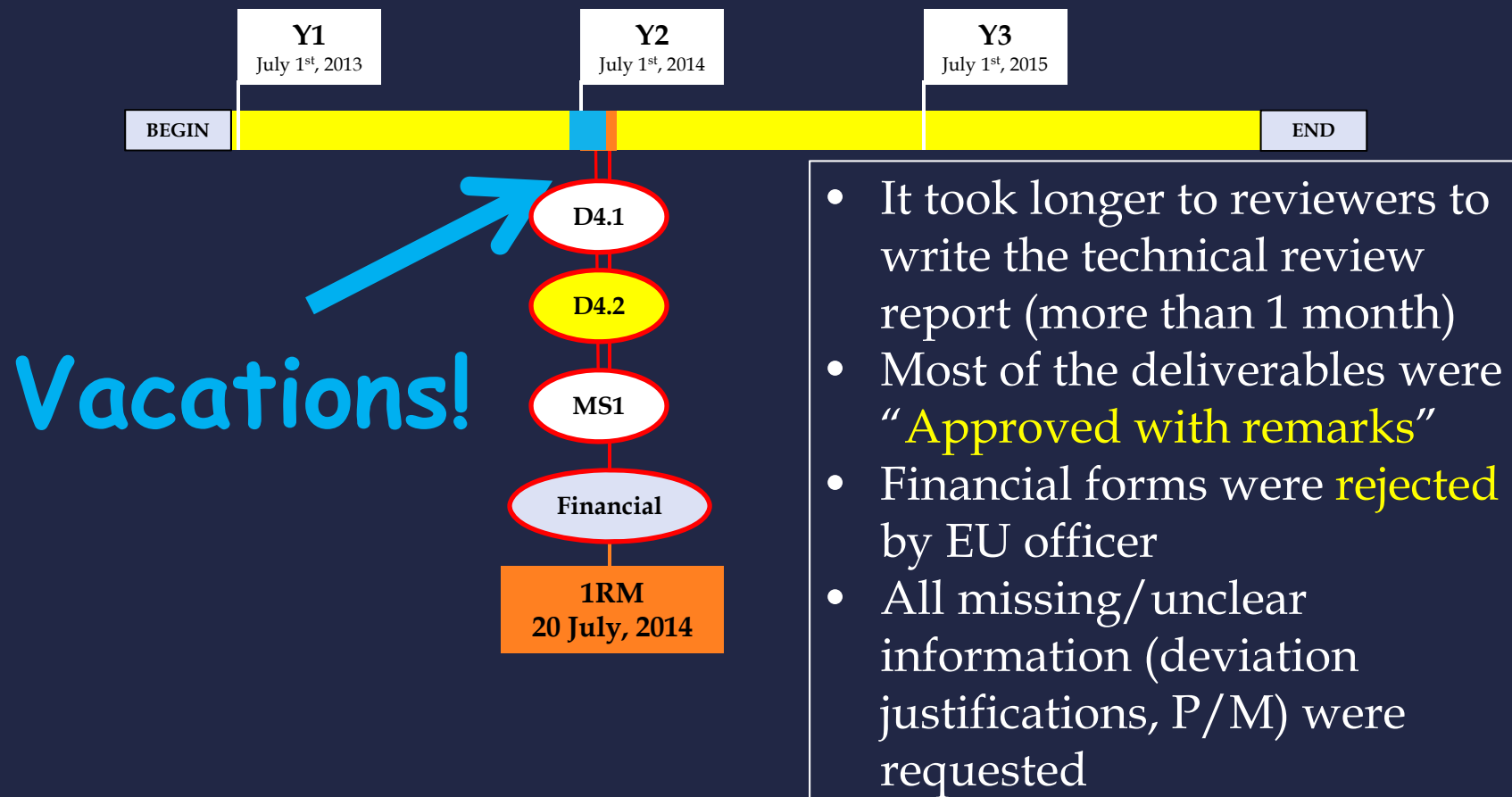

What happened at the first review meetings:



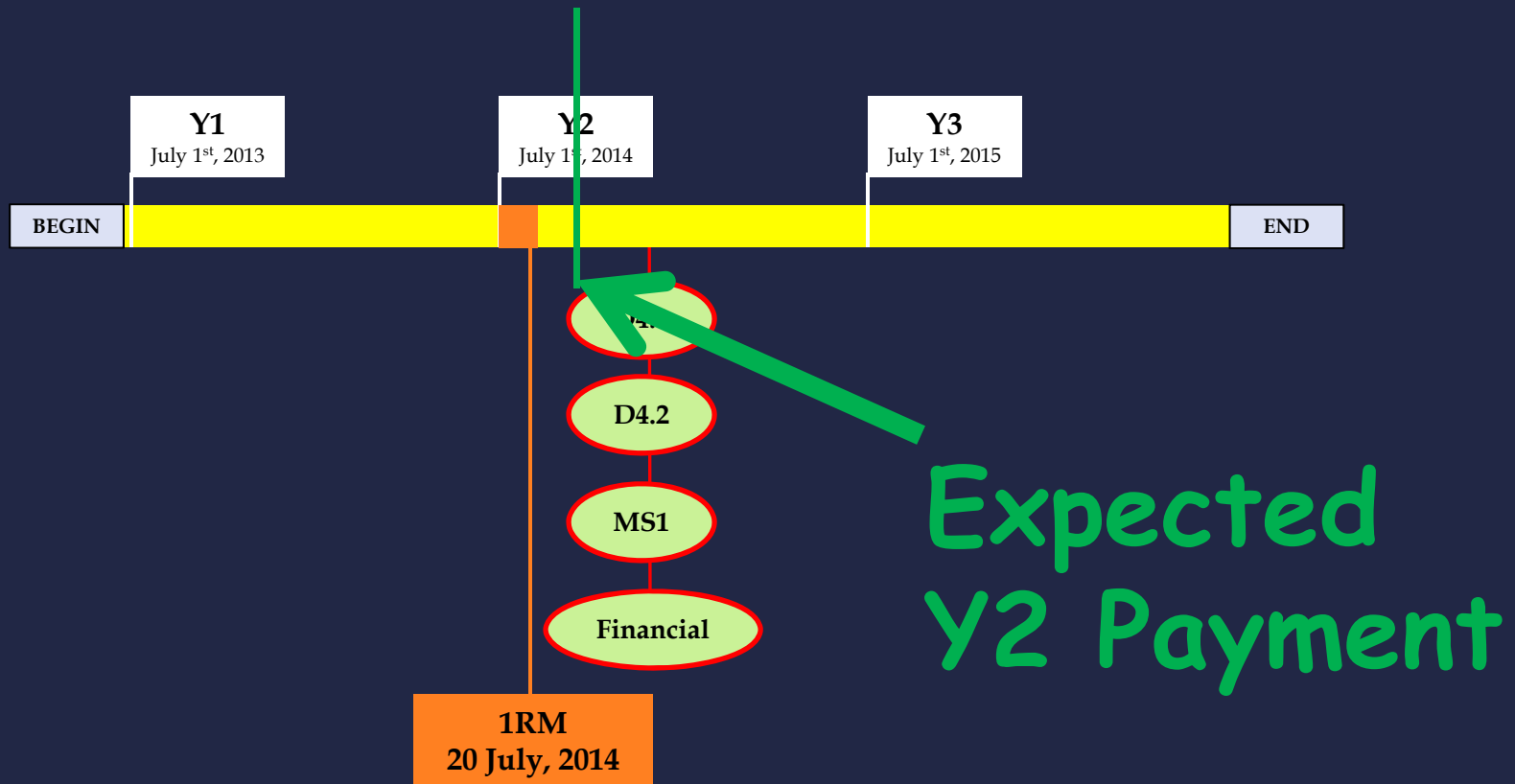

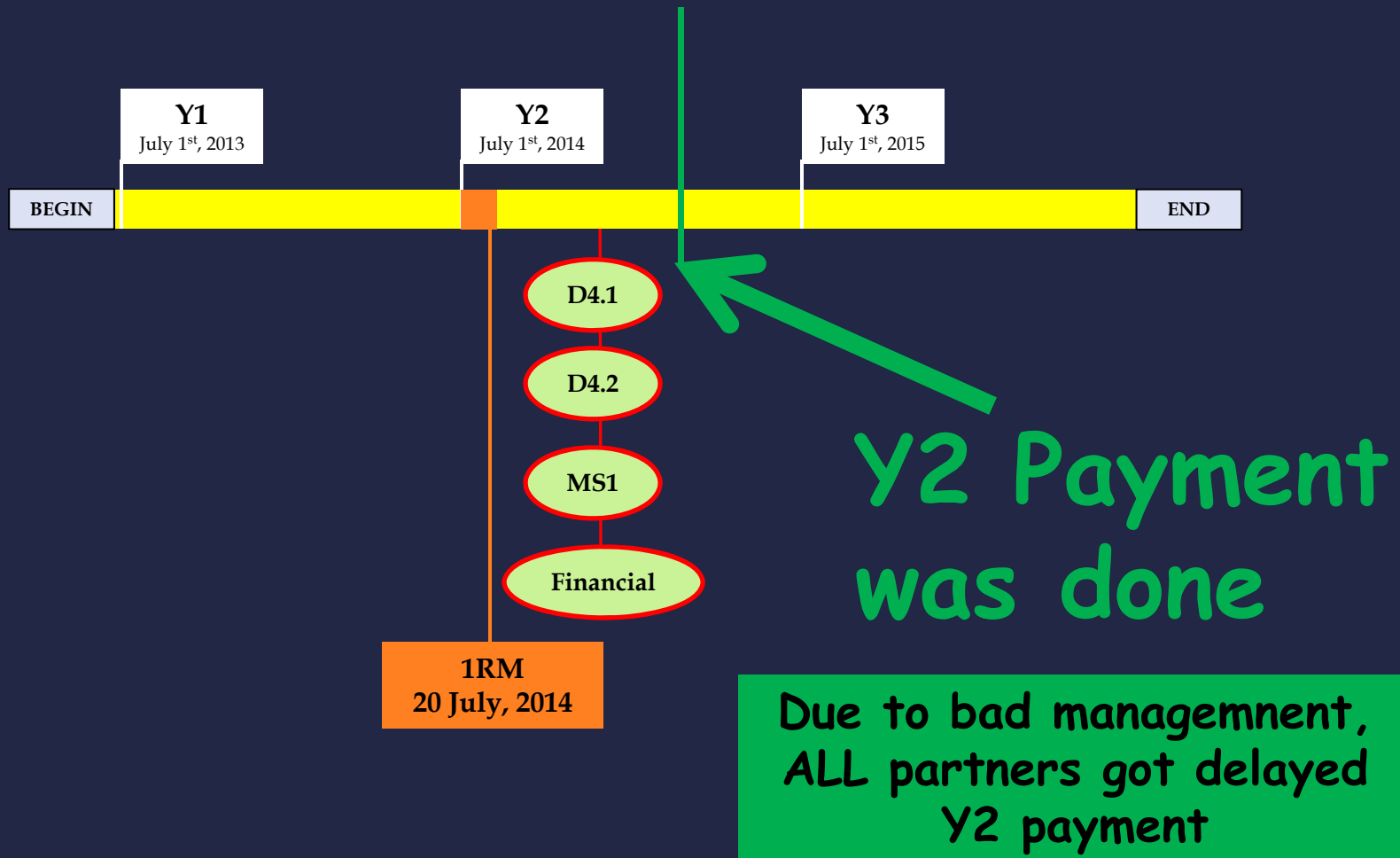

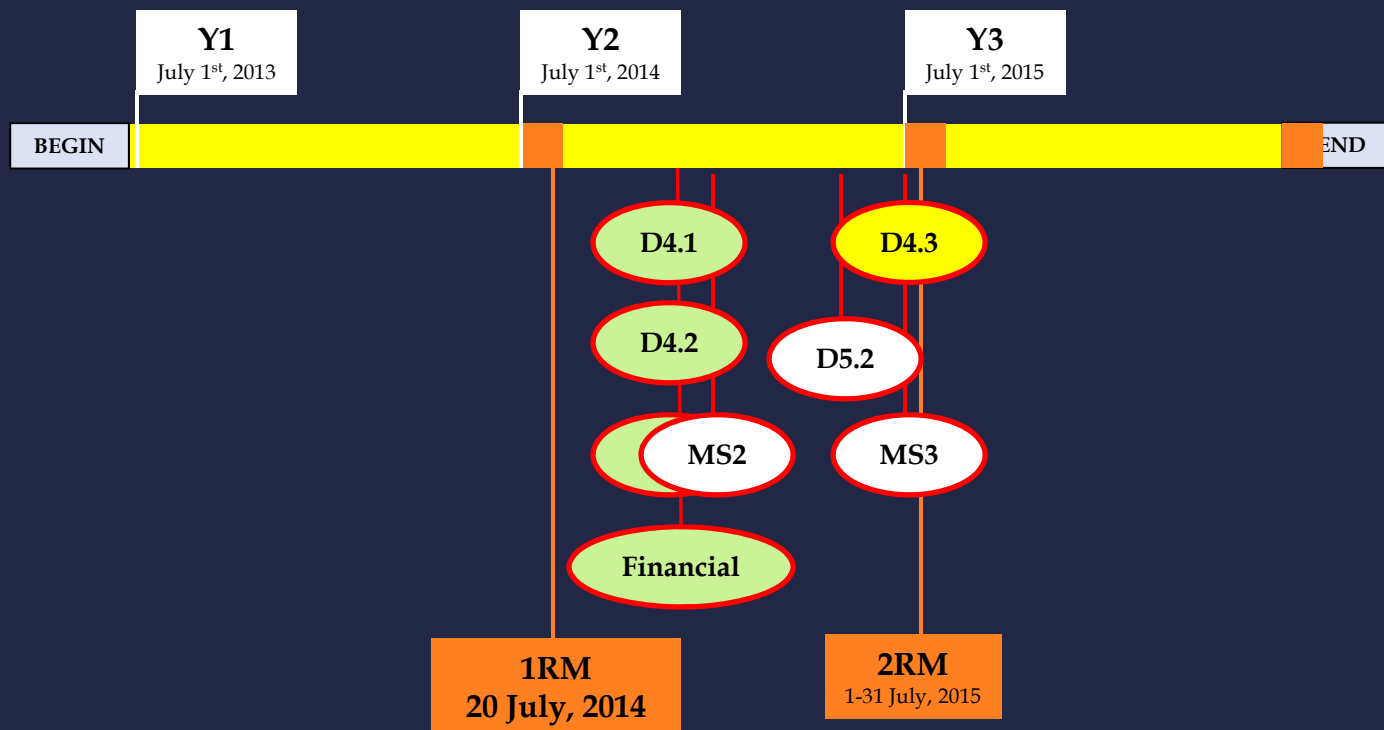

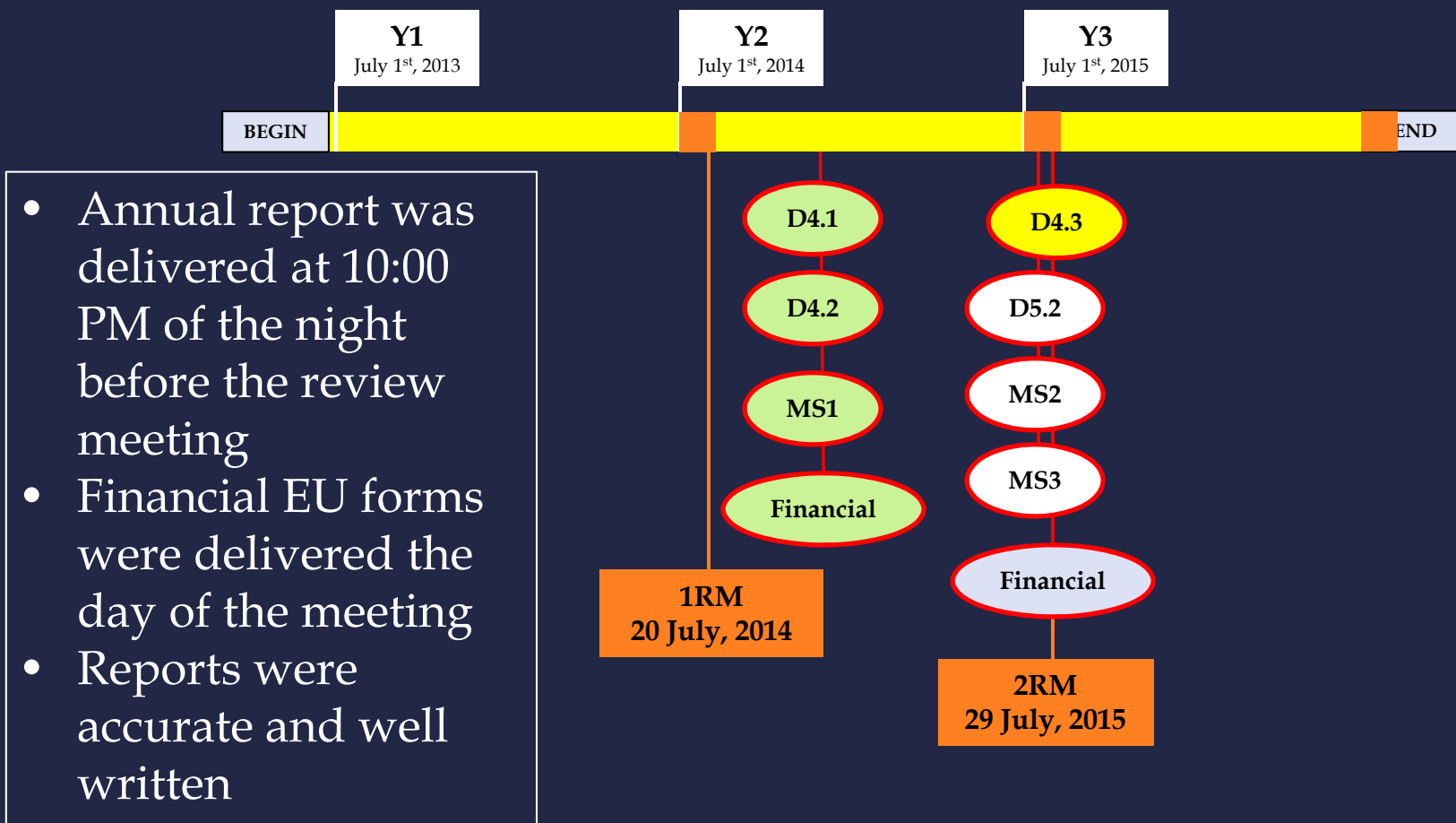

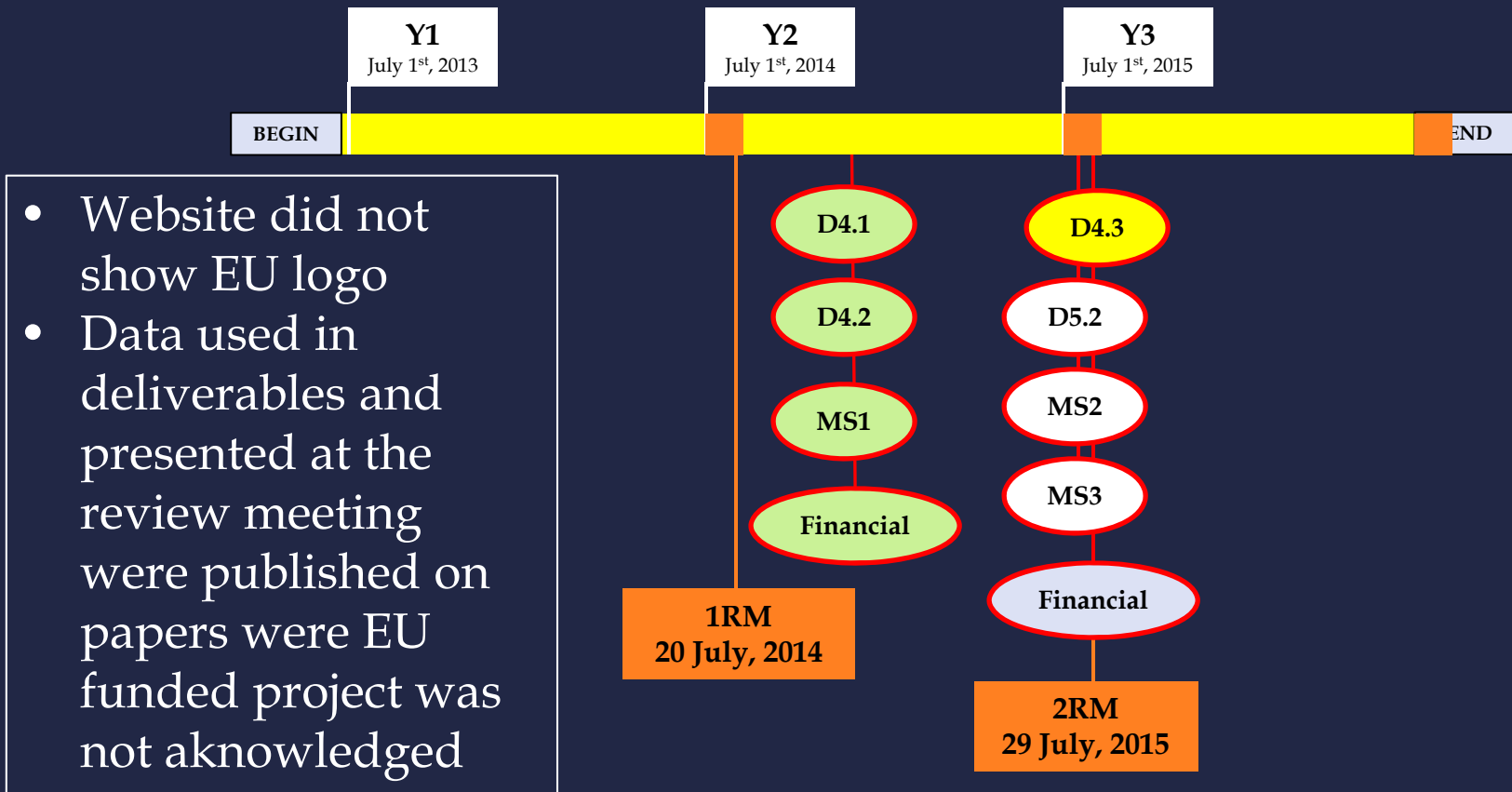

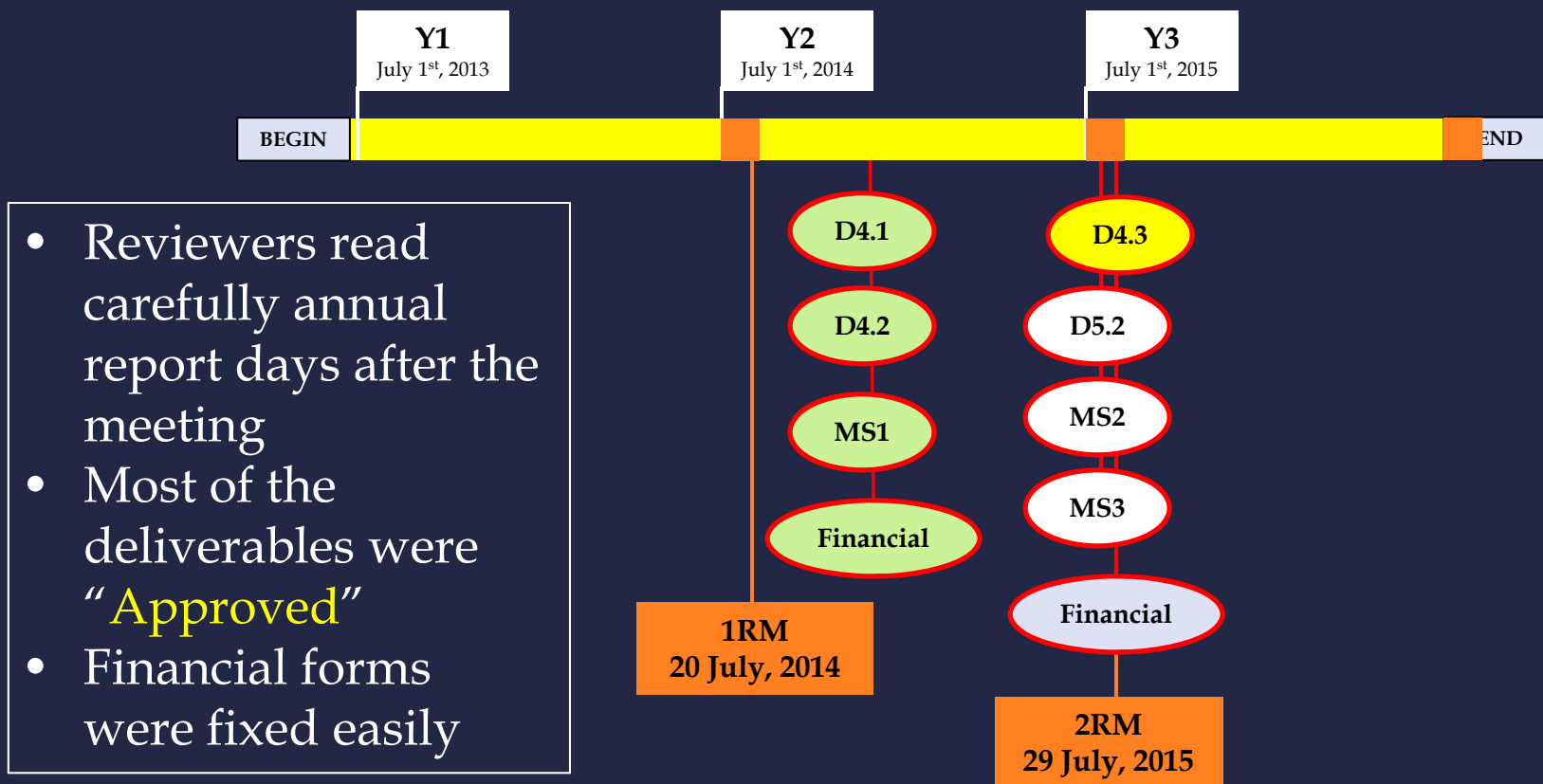

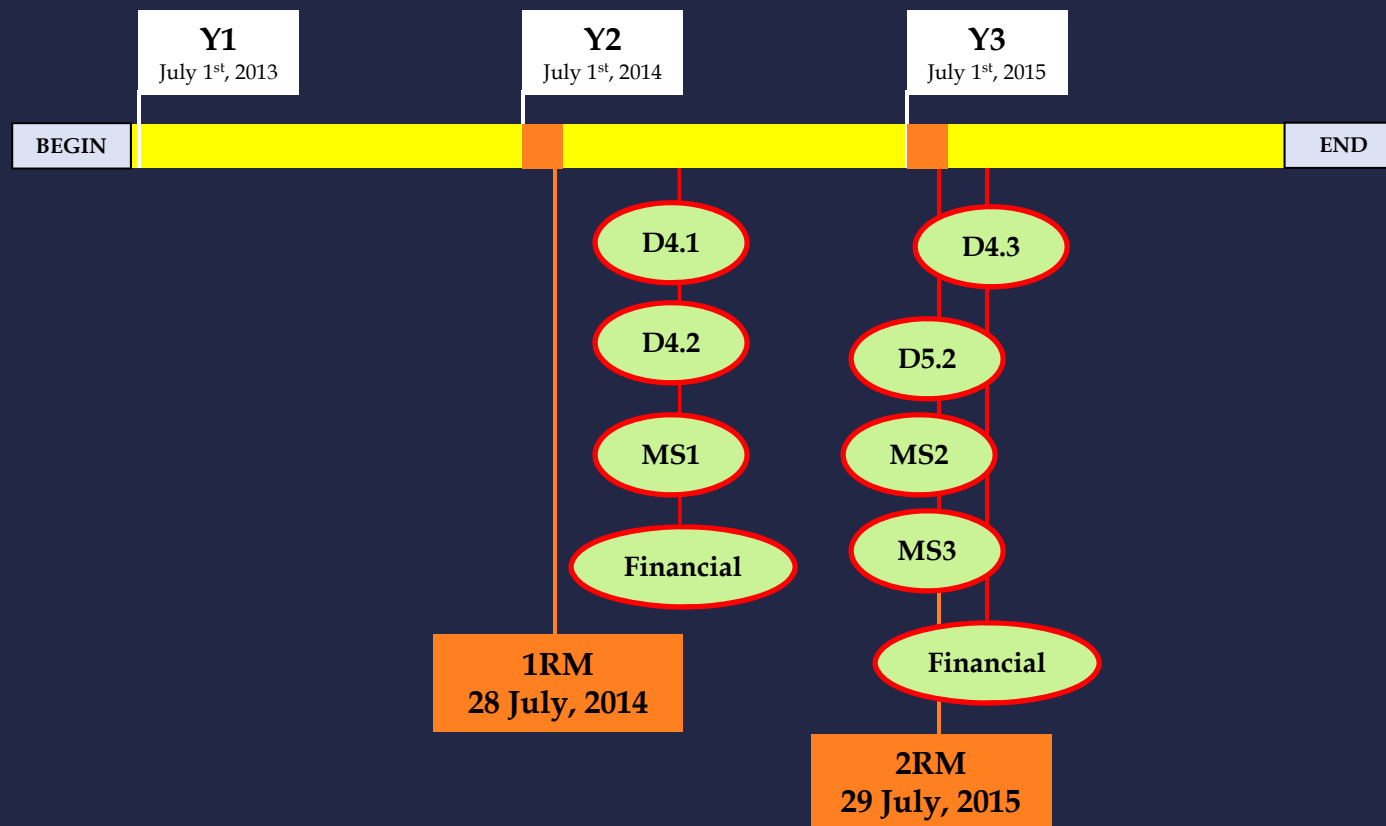

Entrust project management to a SME with specific experience in EU project management

STRATEGY 5

Carefully choose and manage TIME schedule

- Project begin not around holidays/ vacations
- Any delay in deliverables cause delay in reviewers reports
- Delay caused by 1 partner affects ALL partners
