



UNIVERSITY FUND FOR RESEARCH YEAR 2024

CALL FOR THE FUNDING OF INTERDISCIPLINARY RESEARCH PROJECTS

HAVING REGARD TO the resolution of the Board of Directors of 21 December 2023, which in the 2024 budget approved the allocation of € 2.700.000 for the funding of scientific research on the project "Fondo di Ateneo per la Ricerca - Gestione bandi interni - Piano strategico triennale 2023 - 2025 (Azione ricerca 3)" (University Research Fund - Management of internal calls for proposals);

CONSIDERED that these resources shall partly be allocated to those sectors that the academic bodies identify as strategic and fundamental for research activities, in line with the three-year Strategic Plan and the Research Policies;

CONSIDERED that the University is enrolled in the National Research Register under final code 000274_UNIV;

HAVING REGARD TO the resolution of the Academic Senate of 18 December 2019 appointing the University Research Commission coordinated by Prof. Paolo Pavan and composed of Professors Claudio Baraldi, Graziella Bertocchi, Francesca Fanelli, Stefano Lugli, Cecilia Vernia, Marco Vinceti, Michele Zoli, and Dr. Barbara Rebecchi;

CONSIDERED that the Fondazione di Modena considers Scientific and Technological Research as a relevant sector of intervention, as indicated in the Strategic Steering Document 2024-2027.

HAVING ACKNOWLEDGED the agreement between the University of Modena and Reggio Emilia and the Fondazione di Modena for the financing of scientific research projects, file no. Rep. UNIMORE n. 203/2024 Prot n. 127559 dated 23/05/2024;

HAVING REGARD TO the resolution of the Board of Directors of the Fondazione di Modena and the note file no. 121.24.8A dated 11/04/2024 (internal file no. 105333 dated 17/04/2024) with which the Fondazione di Modena communicated that the Board of Directors of the Fondazione has approved the commitment of € 690.000 for the realisation of a joint call for proposals with the University of Modena and Reggio Emilia;

HAVING REGARD TO the proposals put forward by the University Research Commission, which met electronically on 26/02/2024;

HAVING REGARD TO the resolution of the AS of 09/04/2024 approving the proposals of the University Research Commission;

HAVING REGARD TO the resolution of the BoD of 19/04/2024 approving the proposals of the University Research Commission;

CONSIDERED that among the various activities that can be financed by FAR there are interventions aimed at financing "Multi-year interdisciplinary projects on a competitive basis (with anonymous external reviewers)" aimed at stimulating greater participation in competitive research projects;

CONSIDERED therefore the opportunity to issue, on the basis of the provisions of the above-mentioned resolutions, the FAR 2024 call for proposals for the funding of interdisciplinary research projects;

DECREES

ART. 1 - SUBJECT

The present decree regulates the procedures for the funding, by the University of Modena and Reggio Emilia, of research projects presented by its Professors, Researchers on permanent and temporary contracts ex art.24 L.240/2010 (B) and Tenure Track Researchers (hereinafter referred to as Principal Investigator(s), "PI(s)") through the use of a sum allocated to the funding of scientific research included in the 2024 budget estimate and of the funding made available by the Fondazione di Modena.

The programme aims to finance projects of an innovative and interdisciplinary nature that require the collaboration of several Professors/Researchers, in order to promote the strengthening of the scientific basis of the University.

The programme is divided into three funding lines, each with a specifically dedicated budget:

- UNIMORE Line
- UNIMORE-REGGIO Line
- FOMO line.

Within one year from the end of the programme, a University event will be organised during which the results of the approved projects will be presented.

ART. 2 – PARTICIPATION REQUIREMENTS

Each Professor or Researcher may participate, in any capacity, in only one project and in only one of the funding lines (UNIMORE, UNIMORE-REGGIO or FOMO), under penalty of ineligibility of all the projects in which he/she is included.



PIs of a FAR 2022 Mission Oriented project and PIs of FAR 2023 Interdisciplinary Research project are not allowed to participate in any capacity in this call.

Participation in the UNIMORE-REGGIO Line is allowed only to PIs belonging to Departments with administrative offices in Reggio Emilia.

Participation in the FOMO Line is allowed only to PIs belonging to Departments with administrative offices in Modena. Still with reference to this Line, please also note that PIs and members of the research group must not be in the conditions of incompatibility provided for the Bodies and employees of the Foundation by relevant acts and regulations (Statute, General Regulation and Regulation for the resolution of the conflict of interest) available in the "Documentation" section of the website www.fondazioneDIMODENA.it.

ART. 3 – PROJECT DURATION AND START DATE

All projects must have a duration of 24 months with no possibility of extension, starting from 02/12/2024

ART. 4 – PROJECT FEATURES

Submitted projects may address topics related to any research field within the three ERC fields (Life Sciences - LS, Physical, Chemical and Engineering Sciences - PE, Social Sciences and Humanities - SH) and should be inspired by the characteristics of projects supported by the Horizon Europe Framework Programme (FP HE), with a focus on the Horizon Europe Missions (https://research-and-innovation.ec.europa.eu/funding/funding-opportunities/funding-programmes-and-open-calls/horizon-europe/eu-missions-horizon-europe_en)

Projects funded by the programme must address a specific topic of investigation through an interdisciplinary approach and must provide for the activation of at least one research fellowship contract. If publications are envisaged among the research products, at least one of them must be in open access and must be available within the deadline for submitting the results of the funded projects, as set out in art. 1.

The products of research will have to include the following statement: “This work was supported by the Università di Modena e Reggio Emilia – Fondazione di Modena Project “_____” (indicare titolo) funded by Fondo di Ateneo per la ricerca Anno 2024 - Bando per il finanziamento di progetti di ricerca interdisciplinari”.

The total budgets made available by UNIMORE and FOMO are:

- € 690.000 (including € 30.000 for proposal evaluation) for the UNIMORE line
- € 200.000 for the UNIMORE-REGGIO line
- € 690.000 (including € 30.000 for proposal evaluation) for the FOMO line.

The UNIMORE and FOMO budgets are divided among the three ERC macro-sectors as follows:

Projects will receive a maximum funding per project of:

- € 80.000 for the ERC PE and LS;
- € 60.000 for the ERC SH.

Within the overall allocation of the call for proposal, at least one project submitted by PI under the age of 40 at the date of publication of the call will be funded for all funding line (UNIMORE, UNIMORE-REGGIO, FOMO). In the event that no project with PI under the age of 40 is selected for funding at the conclusion of the evaluations, will be selected the project that has reached the minimum score threshold and has obtained the highest score among those not funded due to lack of funds, regardless of the macro-sector it belongs to. The budget for this project will be reserved by proportionally deducting a share from the three macro-sector.

Maternity leave (18 months for each child), parental leave (e.g. paternity leave) and other documented reasons (e.g. long term illness of the PI, more than 90 days) are an exception to the age limits for access to the quota reserved for PIs under the age of 40.

The contribution assigned to the projects deemed worthy of funding shall be entirely managed by the Department to which the PI belongs.

In order to maximize the use of the available budget on the UNIMORE Line, UNIMORE-REGGIO Line, and FOMO Line, any remaining funds in the budget will be combined to finance additional projects that are well placed in the ranking list and meet the characteristics of the call for proposals.

ART. 5 – EVALUATION AND SELECTION PROCEDURE

Regardless of the selected Line, projects will be evaluated by anonymous reviewers and those with a score equal to or higher than **17/20** will be considered eligible for funding. FOMO Line projects eligible for funding based on the anonymous review will undergo a second evaluation by a joint UNIMORE-FOMO committee, coordinated by the Foundation.

UNIMORE and UNIMORE-REGGIO Line Projects.

Stage 1: Projects will be evaluated by a Panel of 3 experts of national and/or international renown, identified from the MUR's REPRISÉ database through an automatic matching procedure that will first associate the ERC subfields and then the CUN keywords (see Art. 10 of this call) indicated at the time of proposal submission. The Research Committee will compare the scores assigned by the three reviewers: the final score will be the arithmetic average of the two scores that are closest to each other, excluding the lowest score if all three scores are equidistant.

Stage 2: projects that pass the first stage will be ranked in three separate lists by ERC fields for the UNIMORE line and in two separate lists by ERC fields for the UNIMORE-REGGIO line. The projects with the highest score will be funded until the available funds for each line are exhausted. Any unallocated budget within an ERC fields will be used to fund the best remaining projects in the ranking list of another ERC fields.

In case of a tie, the project with the PI with less time in university roles will be funded. For this calculation, the first position held at any University shall be considered (Researcher on temporary contracts ex art.24 L.240/2010 (B), Researcher on permanent contract, Associate professor, Full Professor). When calculating the seniority in university roles, periods of maternity leave (with the possibility of deducting 18 months for each child), parental leave (e.g. paternity leave), and other documented reasons (such as long-term illness of the PI, over 90 days) should be considered, with the possibility of deducting the corresponding leave period taken. In case of further tie, in each ERC macro-sector, the project that best ensures gender equality in the overall rank of funded projects will be funded.

FOMO Line projects.

Stage 1: it will follow the same evaluation procedures provided for the UNIMORE Line.

Stage 2: projects that pass the first stage will be evaluated by a joint UNIMORE-FOMO Committee which will apply the additional criteria 4, 5, and 6 described below.

The final score for each project will be the sum of the scores awarded in stages 1 and 2.

Projects will be ranked in three separate lists by ERC fields. The projects with the highest score will be funded until the available funds for each line are exhausted. Any unallocated FOMO budget within an ERC fields will be used to fund the best remaining projects in the ranking list of another ERC fields.

In case of a tie, the project with the PI with less time in university roles will be funded. For this calculation, the first position held at any University shall be considered (Researcher on temporary contracts ex art.24 L.240/2010 (B), Researcher on permanent contract, Associate professor, Full Professor). When calculating the seniority in university roles, periods of maternity leave (with the possibility of deducting 18 months for each child), parental leave (e.g. paternity leave), and other documented reasons (such as long-term illness of the PI, over 90 days) should be considered, with the possibility of deducting the corresponding leave period taken. In case of further tie, in each ERC macro-sector, the project that best ensures gender equality in the overall rank of funded projects will be funded.

The selection of the applications and the determination of the contribution will be made at the sole discretion of the Fondazione di Modena. No appeals, complaints, requests for re-examination or other forms of appeal will be admitted.

FIRST STAGE EVALUATION CRITERIA:

Projects will be evaluated based on the following criteria:

1) Quality of the research project, up to 10 points

Quality of the research project – scientific merit and innovative nature of the project – with particular regard to:

- a) clarity and relevance of the project objectives;
- b) relevance and originality of the proposed project in the specific scientific area;
- c) adequacy of the proposed methodologies and available instrumentation (where relevant), project coherence;
- d) positioning of the project in relation to the state of the art in the specific scientific area.

2) Composition of the research team, feasibility and adequacy of the project, up to 7 points

Composition of the research team, feasibility and adequacy of the project, scientific merit of the research team, feasibility of the work plan and reasonableness of the funding request, with particular regard to:

- a) Principal Investigator's CV;
- b) ability to carry out the proposed project (qualification and composition of the research group, preliminary data, where relevant);
- c) project organization in relation to the proposed objectives, the time deemed necessary for project completion, and the resources required (equipment, personnel, etc.);
- d) consistency and relevance of the budget plan with the objectives and activities.

3) Impact of the project, up to 3 points

Impact of the project, with particular reference, depending on its disciplinary field, to:

- a) challenges that the research addresses in terms of impact on theoretical and/or methodological advancement in the relevant scientific field, or on technological innovation, industrial applications, economic growth, or societal problems, protection of cultural heritage or the environment, also with interdisciplinary approaches;
- b) effectiveness of the research project dissemination activities and its results; project impact on the scientific community and society in light of the objectives defined by the EU's Research and Innovation Framework Program.

SECOND STAGE EVALUATION CRITERIA - FOMO LINE:

The FOMO Line projects will be assessed by a special joint UNIMORE-FOMO committee, which will apply, only to projects deemed fundable by external referees (with a score equal or higher than 17/20) the following additional criteria, in order to determine the final ranking of projects admitted to funding:

Admission criterion 4: Consistency of the policy guidelines of Fondazione di Modena

In order to be eligible for selection, projects must be consistent with the main challenges of the FOMO Strategic Steering Document 2024-2027.

Criterion 5: Impact on human capital, up to 2 points

Adequacy and quality of the proposed activities for the professional growth of the staff involved, with specific reference to the growth of researcher to be recruited.

Criterion 6: Impact on the territory, up to 2 points

Evaluation of the potential impact on the territory, also intended as application, enhancement and use of the knowledge produced to contribute to the social, environmental, health, cultural and economic development of the local community.

Given the interdisciplinary approach, estimation of the project's contribution to developing skills and competences in the field of productive innovation processes, cultural, social or environmental promotion within the context of the province of Modena.

Projects, if funded, will have to produce a final scientific report giving an account of the results achieved.

ART. 6 – PROJECT SUBMISSION

The PIs must submit a detailed research project by **19/07/2024 at 5pm**; the project must be written in English, using only the forms provided by the University. The proposal must be submitted exclusively by the project PI through the online platform, accessible with the PI's university credentials, **starting from 01/07/2024**. The date and time of submission of the proposal shall be the date and time of validation and closure of the application by the PI using the online platform. By validating and closing the application, the PI consents to make the project proposal available to the external evaluators, as well as to make the project proposal and the assessments made by the external evaluators available to the members of the University Research Committee, the Senatorial Research Committee and the UNIMORE-FOMO Joint Committee.

The PI shall send to the National Research Office, by the same deadline, the resolution of approval of the proposal by the Department or a letter of approval by the Director of the Department itself, to be ratified at the first useful meeting of the Council.

Projects that do not comply with the specified forms (in particular, the maximum and minimum character count, the criteria set out in the operating instructions for the management and reporting of projects funded by FAR, the rules for the participation of teaching and research staff, and those submitted after the deadline) will be automatically excluded from evaluation. **Applications submitted via email or through channels other than the one indicated above will not be considered.**

Applicants shall declare, under their own responsibility and under penalty of exclusion from the call, whether their project requires the approval of the Ethics Committee (based on the project's characteristics, it will be submitted to either the Comitato Etico di Area Vasta Emilia Nord or the Comitato Etico di Ateneo per la Ricerca). If a project requiring Ethics Committee is selected and funded, the project activities will begin the day after obtaining approval from the Committee.

ART. 7 - APPROVAL OF UNIMORE AND UNIMORE-REGGIO LINE PROJECTS AND FUNDING AMOUNT

The Research Commission may fund projects that have been deemed suitable even to a lesser extent than requested, if deemed appropriate.

The lists of funded projects will be approved and disclosed by a specific Rectoral Decree.

ART. 8 - APPROVAL OF FOMO LINE PROJECTS AND FUNDING AMOUNT

The Fondazione di Modena, through the evaluation of the relevant Joint Committee, reserves the right to finance the individual projects that have been found to be suitable following the two-stage evaluation process, even to a lesser extent than that requested, if deemed appropriate.

The Foundation shall notify the University of the list of funded projects, which shall be disclosed by a specific Rectoral Decree. The project management is entrusted to the PI's Department.

ART. 9 - PROJECT MANAGEMENT AND REPORTING

The PI is responsible for the scientific management of the project, ensuring its implementation within the timeframe and methods indicated in the application.

The PI may submit a request for remodelling during the course of the project by sending an email to ricercanazionale@unimore.it. This request will be forwarded to the Research Commission for projects funded under the UNIMORE and UNIMORE-REGGIO Lines and to the Fondazione di Modena for projects funded under the FOMO Line.

Extension requests will not be accepted.

Within three months from the end of the project, the PI shall submit a detailed scientific report, complying with the specifications set out in the appropriate forms, on the results obtained, the staff employed on the project funds and the scientific communications made.

Together with the scientific report (within three months of the end of the project), the PI must submit the accounts, together with copies of the duly receipted supporting documents. Expenditure must have been incurred within the project duration and paid by the end of the reporting period.

Pursuant to the Modena Foundation's Regulations and in line with its general guidelines on evaluation, the grant is awarded subject to the correct completion and submission of the end-of-project report form.

Both the scientific report and the accounting report shall be sent in electronic format to the National Research Office: ricercanazionale@unimore.it.

The project design, management, and reporting shall be carried out in accordance with the operational guidelines provided for projects using FAR funds of the University published at the following link <https://www.ricerca.unimore.it/site/home/ricerca-nazionale/unimore.html>.
